**Directions: POST CODE: BD17 5BN From Keighley direction:-** Travel on the A650 dual carriageway from Keighley towards Bingley. Take the sliproad signed for Eldwick, Gilstead, and Bingley railway station. At the end of the sliproad, turn left, signed Eldwick / Gilstead, and up the hill. Keep following that road (straight across a roundabout) until you come to a mini-roundabout. Turn right into Otley Road. Keep on that road until, immediately after a dip on a right-hand bend, turn right into Spring Lane (also shown by a brown direction sign to ShIPLEY GLEN). Stay on Spring Lane until a right turn into Glen Road. The trial is to be held near the bottom of this road. **From Bradford direction:-** Travel on the A650, turning right onto A6038/Otley Rd. Take a slight left at B6151/Baildon Road and continue to follow the B6151. At the roundabout, take the 2nd exit onto The Grove; then a slight left at Newton Way. Continue on West Lane. Continue on Lucy Hall Drive. Turn right into Glen Road. The trial is to be held along this road. **Parking** is available at various places along Glen Road. Please park sensibly and carefully – do not park on the grass.
